

**ORDINANCE \_\_25-2024\_\_**

**AN ORDINANCE SPECIFYING THE APPROVAL OF THE COUNCIL OF THE VILLAGE OF DELTA, FULTON COUNTY, OHIO, OF THE PENDING ANNEXATION PETITION NO. 2024-3 OF HIDIE BOWMAN, ROGER BOWMAN, AMY BOWMAN AND CODY BOWMAN TO ANNEX PROPERTY TO THE VILLAGE OF DELTA, FULTON COUNTY, OHIO, AND DECLARING AN EMERGENCY.**

WHEREAS, Hidi Bowman, Roger Bowman, Amy Bowman and Cody Bowman has caused to be filed Petition No. 2024-3 with the Commissioners of Fulton County, Ohio; and

WHEREAS, this Council is desirous of expressing its approval and acceptance of said annexation petition as filed herein;

**NOW THEREFORE, Be It Ordained By The Council Of The Village of Delta, Wood County Ohio, That:**

**SECTION I:** That the petition for annexation of certain lands titled to Hidi Bowman, Roger Bowman, Amy Bowman and Cody Bowman to the Village of Delta, Fulton County, Ohio from Pike Township, Fulton County, Ohio, has been filed with the Fulton County Commissioners and captioned Annexation Petition No. 2024-3, attached as Exhibit A.

**SECTION II:** This Council hereby expresses its consent and approval as to the annexation of said lands to the Village of Delta. Further, this Council states that by separate Resolution No. \_\_\_\_\_ it has heretofore agreed to provide Village utility and police services to said lands once same are annexed to the Village of Delta, Fulton County, Ohio.

**SECTION III:** The express intent of Council herein is in conformity with ORC §709.023(D) and/or all applicable law.

**SECTION IV:** It is hereby found and determined that all formal actions of this Council including any of its committees concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal actions as contained herein were and are in compliance with all legal requirements as set forth by Village Charter.

**SECTION V:** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said Village and its inhabitants and for the further reason that annexation of said territory provides for the controlled orderly growth and development of the Village and that it is necessary to meet the time requirements set forth in the Ohio Revised Code.

WHEREFORE, this Ordinance shall take effect and be in full force immediately upon its passage and approval.
