RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY

WHEREAS, The Fulton County Budget Commission of Fulton County, Ohio, has established the Tax Budget for the next succeeding fiscal year commencing January 1st, 2024.

WHEREAS, The Fulton County Budget Commission of Fulton, County, Ohio, has certified its action thereon to this Board together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Board, and what part thereof is without, and what part within, the ten mill limitation:

NOW THEREFORE BE IT RESOLVED, By the Council of the Village of Delta, Fulton, County, Ohio.

SECTION 1: By the Council of the Village of Delta, Fulton, County, Ohio, the amounts and rates as attached on schedule A, and as determined by the Fulton County, Ohio Budget Commission in its certification, be and the same are hereby accepted; and be it further

SECTION 2: That there be and is hereby levied on the tax duplicate of said County the rate of each tax necessary to be levied within and without the ten-mill limitation as listed on attached Schedule B:

SECTION 3: It is hereby found and determined that all formal actions of this Council including any of its committees concerning and relating to the adoption of this Resolution were in an open

meeting of this Council and that all deliberations of this council and any of its committees that resulted in such formal actions as contained herein were and are in compliance with all legal requirements as set forth by Village Charter.

SECTION 4: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of said Village and its inhabitants and for further reason that is necessary to meet the certification deadline to the Budget Commission, Fulton County, Ohio for the funding requirement.
